(With a spread of 46 basis pts. (ii) Commitment Charges payable on the undisbursed loan amount-0.75%. Bank have been notifying waiver of 0.50% since july,91. (iii) Front End Fee -1% (one time payment) of loan amount is payable in respect of loans negotiated after 1.7.1998.
